Above financial up-gradation under the MACP Scheme shall be subject to the terms and condition mentioned in DoP&T OM No. 35034/3/2015 -Estt.(d) dated 22/10/2019 and further instructions/ clarification issued from time to time and circulated by Establishment Branch -III, Hqrs. Office on the subject. Further, the cases of the officials holding a higher post on purely ad-hoc basis before the date of recommendation of financial up-gradation, if, any, may be regulated as per para 25 of Annexure -I of DoP&T OM dated 22/10/2019.

On up-gradation under the MACP Scheme, pay of an employee shall be fixed as per para 4 to 7 of Annexure-I DoP&T OM dated 22/10/2019 and the officials shall have to exercise the option of fixation of pay within one month from the date of issue of order, under the provision of FR 22 (I)(a)(1).
